### Terms & Conditions

- 1. HOW TO ENTER.** Visit your local branch between 2/6/26 and 12/31/26, and fill out an entry form to be entered into the drawing. Limit 1 entry form per member, beginning on 2/6/26 and ending 12/31/26. New entry forms must be turned in at your local branch by lobby closing on the last day of the month, in order to participate in the current month's drawing. If the last day of the month falls on a weekend, entry forms for that month must be turned in by 12:30pm on Saturday. 1 wallet recipient will be drawn at random by the Marketing Department for each month. If you were not selected during a particular month, your entry form will be placed back into the drawing for additional chances to win throughout the year. Only 1 entry form should be completed per eligible member between 2/6/26 and 12/31/26. Prize recipients will be notified on or about the 15<sup>th</sup> day of the month following the month of entry form submission. Prize must be picked up in person at the member's branch of choice. **NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.**
- 2. PRIZE.** One (1) winner will be drawn at random from all completed entry forms at the end of each month from February 2026 to December 2026, for a total of 11 winners as of 12/31/26. Prize will consist of a wallet filled with various merchant gift cards totaling \$90, and must be picked up at the winner's nearest First Financial branch.
