

MORE THAN EIGHT DECADES OF SERVICE TO OUR COMMUNITIES!

During the Depression, a group of Asbury Park school teachers organized a credit union. This unique financial cooperative, called Monmouth County Teachers Federal Credit Union, was designed to provide savings and loan services at a higher return and a lower cost to its members than traditional banks. Its structure was also unique with an unpaid Board of Directors and Supervisory Committee.

Back in 1936, money was tight and many people were leery of big banks. Volunteers who ran the credit union collected nickels and quarters each payday to build members' savings accounts and then lent it out to other members. The concept was simple but...it worked! In the mid-sixties, when the credit union expanded to also serve teachers in Ocean County, the name changed to Mon-Oc Teachers Federal Credit Union. It was eventually shorted to Mon-Oc Federal Credit Union to reflect the addition of public employees and local students to the charter.

In 2002, the credit union was given permission by the National Credit Union Administration to expand its charter to serve everyone who lives, works, worships or attends school in Monmouth County or Ocean County. During the summer of 2006, the name "Mon-Oc" was retired as the credit union changed its name to First Financial. The new name reflects the organization's commitment to focusing on first-rate service, first class professionalism and considering the financial needs of its members first and foremost. Member surveys consistently rank the credit union with an exceptionally high level of member satisfaction.

First Financial offers a full range of financial services—from Checking and Money Market Accounts to Mortgages and Credit Cards and 24/7 Online Banking to an Investment & Retirement Center. While the face of First Financial has changed through the years, the heart and soul of the credit union—its members and volunteers—remain the same. A strong philosophy of service is still the driving force behind First Financial.

The strength of the credit union is the result of individuals working together to provide themselves and their families with a better way of life. First Financial is a living testament to the members and volunteers who have made the dream possible.
