

## **200<sup>th</sup> New Member of 2019 Trip Getaway for Two Eligibility, Trip & Pricing Options, General Disclosures**



### **ELIGIBILITY**

A new First Financial membership is required to be eligible for 200<sup>th</sup> New Member of 2019 Getaway (Getaway). A First Financial Membership is open to anyone who lives, works, worships, volunteers, or attends school in Monmouth or Ocean Counties, NJ. The new membership must be opened in person at one of our branches. New member must open a first time base savings account with minimum \$5.00; in addition to a new full relationship checking account or new loan. Full relationship checking account includes full direct deposit, debit card, e-statements, and enrollment in Online Banking. New loan must have a minimum balance of \$12,000. Existing Members opening secondary memberships are not eligible for Getaway. Any person re-opening a closed membership is not considered a new membership and is not eligible for Getaway. Indirect members, opening their membership through a partnered auto dealer, are not eligible for Getaway. Members opening Custodian, Guardianship, Estate, and Trust Accounts are not eligible for Getaway. Business memberships are not eligible for Getaway. Current Employees, Board and Supervisory Members, relatives of Employees/Board/Supervisory or persons living in same household are not eligible for Getaway. The 200<sup>th</sup> new member must be at least 18 years of age. The member, who opens the Credit Union's 200<sup>th</sup> eligible new membership of 2019 with full relationship checking account or new loan, may choose one of the following Getaway options by 12/31/19 (up to \$2,500 value):

### **TRIP OPTIONS**

*Hilton Head, South Carolina: 2 People, 5 days/4 nights*

*Las Vegas, Nevada: 2 People, 5 days/4 nights*

*Walt Disney World, Florida: 2 People, 5 days/4 nights*

*Bahamas/Bermuda Cruise: 2 people, 6 days/5 nights*

### **GETAWAY WINNER ANNOUNCEMENT**

The 200<sup>th</sup> eligible new membership will be determined after month end reports are reviewed by the Credit Union. The member opening the 200<sup>th</sup> eligible new membership will be contacted by phone by our Marketing Department within 2 weeks of determination. The member will need to visit their nearest branch to redeem their chosen Getaway. In the event we are unable to contact winner within 2 weeks of determination, via phone number provided at account opening, they will forfeit their right for trip redemption and the next eligible member will be contacted.

### **GENERAL CONDITIONS**

The Credit Union will cover the cost of hotel and flight for winning member and companion of their choosing, up to \$2,500 value. Costs for additional travelers, additional nights, transportation (of any kind other than flight), food, and excursions will be the responsibility of the member. Travel must be booked by 12/31/19. New membership and checking account or loan must remain open for 6 months. In the event of account closure or payoff prior to 6 months, the member agrees to pay back the value of the Getaway in full. By accepting the prize, the winner and companions agree to release and hold harmless First Financial Federal Credit Union and its subsidiaries and advertising and promotion agencies from any and all liability including all claims arising from, but not limited to injuries or damages of any kind sustained in connection with the acceptance, enjoyment and/or use or misuse of any prize(s) received in this promotion.
